





## World economic growth








# Smoking prevalence in Suriname






Survey	Year	Male	Female
STEPS (adults)	2013	34.0%	6.5%
Global Youth Tobacco Survey (age 13-15)	2009	20.7%	16.6%
Global Youth Tobacco Survey (age 13-15)	2016	17.1%	7.3%



# Tobacco excise tax systems





- Ranked from most efficient to least efficient
  - Uniform specific tax
  - Ad valorem (or mixed) tax system with minimum specific floor
  - Mixed tax system
  - Pure ad valorem tax
  - Tiered tax systems ("gelaagde belastingstelsel")
  - No excise tax system




# Tax reform in the Philippines

# Tax increases in Australia






#### This is the tobacco excise increase schedule:

December 2013	12.5 per cent

September 2019	12.5 per cent
September 2020	12.5 per cent

# Excise taxes in Suriname





- Cigarettes: 66 USD per 1000 sticks
- Cigars and cigarillos: 66 USD per 500 sticks
- Other tobacco: 66 USD per kilogram

#### NOTE:

The excise tax rates have remained unchanged since 2011

Import duty	Mostly zero (CARICOM exemption)
Consumption of cigarettes (sticks)	103 million sticks
Total adult population (15+)	434 000
Total prevalence (Adult)	17%
Price elasticity of demand	-0.4 (premium) to -0.8 (economy)
Substitution to lower-priced cigarettes possible?	Yes, through cross-price elasticity
Industry response to change in excise tax	Full pass through

Consumption (illicit, sticks)	103 million	105,8 million	3%
Consumption (total, sticks)	206 million	196,5 million	-5%
Excise tax revenue	SRD 159,1 million	SRD 210,1 million	32%
Total tobacco-related revenue	SRD 197,5 million	SRD 252,2 million	28%
Smoking prevalence	17%	16,61%	-0,39 percentage points
Number of premature deaths avoided		265

# A very rough guestimate of the size of the illicit market






Total adult population	434 000
x Smoking prevalence	17%
x Average number of cigarettes smoked per day	8
x Days in the year	365
Total (legal plus illicit) consumption	215 million
Total legal consumption (2020)	103 million
Total illicit consumption	112 million
Illicit market as percentage of the total market	52%


