Said Adejumobi (Professor) is the Director of the United Nations Economic Commission for Africa (UNECA) Sub-regional office for Southern Africa based in Lusaka, Zambia. Previously he was the Director of the Governance and Public Administration Division (GPAD) at the UNECA headquarters in Addis Ababa, Ethiopia. He holds a PhD in Political Science and taught for about two decades before joining the UN. He also served as Governance Adviser to the ECOWAS Commission in Abuja, Nigeria. He has published extensively on issues of governance, democracy and development in Africa including eight books and about 70 articles in international journals and chapters in books.

Fola Adeleke is currently the head of research at the Mandela Institute at Wits University. He holds a PhD in International Investment Law from the University of Witwatersrand, Johannesburg and has an LL.B and LL.M in Commercial Law from the University of Cape Town. He has worked as Head of Research at the Supreme Court of Appeal, South Africa, the Open Democracy Centre, South Africa and was previously the Head of Programme of the Right to Information Unit at the South African Human Rights Commission. He is also a member of the Access to Information working group of the African Network of Constitutional Lawyers, and the African Network of International Economic Law. His areas of interest are open government, corporate transparency especially in the extractives sector, corporate social responsibility, constitutional and administrative law, Africa's trade, investment, and industrial policies.

João Samuel Caholo is a geoscientist (hydrocarbons) by training, born 10th July 1956 in Angola, Moxico Province. He read Geology at School of Mines, University of Zambia (1976-78), University of Angola (1979-84) and University of Trondheim, Norway post graduate, 1986-87. He is the former SADC Deputy Executive Secretary, Deputy Executive Secretary, Regional Integration, Director of the Energy Commission, Acting Director of Infrastructure and Services, Sector Coordinator and Consulting Petroleum Geologist with close to more than three decades of service to regional Cooperation and Integration in Africa and Southern Africa in particular. Caholo is currently non-executive chairperson of the Board, Sonangol Exploration and Production, Senior Advisor to the President of the PTA Bank and Advisory Board Member of the ISCM Foundation. Caholo's professional focus is on Strategic Scenario Planning, Development and Regional Integration issues, Market Liberalization/Access and Resource Mobilization.

Marianne Camerer is the Programme Director of Building Bridges, the new policy-focused research and outreach programme at the GSDPP. Prior to joining UCT, Marianne co-founded the international anti-corruption NGO Global Integrity and serves as a trustee of The Global Integrity Trust. She previously headed anti-corruption research at the Institute for Security Studies (ISS), was a founding director of the Open Democracy Advice Center (ODAC) and lectured in applied ethics at the University of Stellenbosch. Marianne has consulted for international organizations such as the World Bank and United Nations. She holds masters' degrees in public policy and political philosophy from Oxford and the University of Stellenbosch and has published in the governance field. Her Ph.D. in

Political Studies, from the University of Witwatersrand, was on “Corruption and Reform in Democratic South Africa” with a particular focus on the arms deal. Marianne is a Yale World Fellow and spent a semester in New Haven as a Fellow of the Yale Council on African Studies. She is passionate about leadership development and trained as an integral coach through UCT’s Centre for Coaching at the Graduate School of Business. Marianne is on the Advisory Board of the Centre for the Advancement of Public Integrity (CAPI) at Columbia Law School and the Allard Prize for International Integrity at the University of British Columbia.

Caesar Cheelo is an Economist and the Senior Research Fellow at the Zambia Institute for Policy Analysis and Research (ZIPAR). He is also Associate Executive Director at the Southern African Institute for Policy and Research (SAIPAR) and Associate Editor for two of its journals, the Zambia Social Sciences Journal (ZSSJ) and the Southern African Journal of Policy and Development (SAJPD). Caesar was previously a Macroeconomics/Regional Adjustment Consultant at the COMESA Secretariat. Before that he was a Lecturer and Researcher in the Department of Economics, University of Zambia (UNZA) and as Coordinator of the Health Economics Research and Training Programme also at UNZA. Caesar’s main research interests are in macroeconomics and structural transformation, international economics and regional integration, and energy and health economics. He has over 10 years applied research, policy analysis, and training in these areas. He is seasoned in managing large and medium scale research, policy analysis and knowledge projects, having worked with senior staff at research, policymaking, implementing, communications and funding institutions.

Benjamin Chibuye is currently Country Economist (Zambia) at the International Growth Centre (IGC). Prior to taking up his current role at the IGC, he served as Program Manager at Clinton Health Access Initiative (CHAI) working on the Demand Driven Evaluations for Decisions (3DE) program. He also worked on several joint University of Zambia and Institute of Health Metrics and Evaluation (IHME) research projects, including the GAVI Full Country Evaluation, and as a Teaching Assistant at the University of Zambia. He obtained his Master of Arts degree in Economics from the University of Zambia under the Bank of Zambia scholarship. His main focus is on providing high quality program management, empirical evidence for policy impact, advice on policy, research and Monitoring and Evaluation.

Dennis Chiwele (Dr) holds a D.Phil. from the University of Sussex in Development Economics, a masters of arts in international economics from the International University of Japan and a Bachelor’s of arts in economics from the University of Zambia. He is Country Manager for the International Growth Centre in Zambia (IGC-Zambia). In this role he oversees the Zambia research programme on inclusive growth for the IGC based at the London School of Economics in collaboration with the University of Oxford. The IGC promotes academically top class research with policy relevance and is based in 14 countries in Asia and Africa including Zambia. The Zambia research programme is focused on industrial growth, urbanisation, state capability and energy. He is also one of the principals at RuralNet Associates Limited, a Zambian consultancy firm with special focus on rural development, a position he has held since 1999. He has consulted widely in this capacity in Zambia and the region on sustainable livelihoods and the interaction of local development processes with country and global wide economic developments. Dr Chiwele teaches international trade as part of a Masters course in Economic Policy Management at the University of Zambia.

Maude Dikobe is a gender and cultural consultant and currently the Chairperson of Gender Policy and Programme Committee (GPPC) at the University of Botswana. She has run courses, such as the SADC Gender and Development Course, which attracted people from middle management in the SADC region. In addition, she has collaborated with other experts to run numerous workshops on gender mainstreaming, which are aimed at ensuring that gender issues, awareness and promotion of

gender equity are considered and incorporated in all projects and activities of a given organization. Her research interests among others focus on: Policy, gender and culture and their implication on gender equality in all spheres of life especially in education. She welds intensive expertise in gender-mainstreaming by virtue of working with regional and international organizations interested in promoting equality between men and women. She contributed tremendously to the drafting and passing of the SADC Gender and Development Protocol by working closely with Gender Links, which is the regional alliance movement which challenges gender inequalities in the SADC region.

Vusi Gumede is professor at the University of South Africa and Head of the Thabo Mbeki African Leadership Institute. He previously was an associate professor at the University of Johannesburg. Among other lecturing jobs, he lectured public policy, during 2009-2014, at the erstwhile Graduate School of Public and Development Management of the University of Witwatersrand in South Africa. He worked for the South African government, in various capacities, for about 10 years. Before that, he was a researcher at the National Institute for Economic Policy – he had also taught economics at the University of Durban-Westville where he obtained his Masters of Commerce in Economics. He is affiliated with numerous institutions, including as board member for Southern Africa Trust and ActionAid South Africa. He is also a fellow in various institutions, including the Mapungubwe Institute for Strategic Reflection and the Molefi Kete Asante Institute for Afrocentric Studies, and also serves in various committees & institutions as advisory committee member etc. He has also been, among other things, a Distinguished Africanist Scholar with the Institute for African Development at Cornell University and a Yale World Fellow with Yale University, among other fellowships and or visiting scholarships. He holds postgraduate qualifications in economics and policy studies, including a PhD in economics (2003). His publications are mostly in macroeconomics and political economy.

Alan Hirsch is director of the Graduate School of Development Policy and Practice. He was born in Cape Town and educated in Economics, Economic History and History at UCT, Wits and Columbia. After research and teaching at UCT, Hirsch joined the South African Department of Trade and Industry in 1995, managing industry and technology policy. He moved to the Presidency in 2002, managing economic policy, represented the Presidency at the G20 and was co-chair of the G20 Development Working Group. He has served or serves on several boards, and is associated with a range of policy research initiatives including the International Growth Centre for which he is the Zambia Country Director and the European Centre for Development Policy Management. He was a visiting scholar at the Harvard Business School, was a regular visiting professor at the Graduate School of Governance at Maastricht University and a member of the OECD secretary-general's Inclusive Growth Advisory Group. Professor Hirsch writes about economic development issues, including Season of Hope – Economic Reform under Mandela and Mbeki and recently co-edited The Oxford Companion to South African Economics.

Faizel Ismail is Adjunct Professor at the University of Cape Town, School of Economics on a part time basis. He holds a PHD in Politics from the University of Manchester, an M. Phil in Development studies, IDS Sussex and a BALLB from UK-ZN (PMB). He served as South Africa's ambassador to the World Trade Organisation from 2010-2014. He has 20 years' experience in trade negotiations, trade policy and industrial development where he worked in the department of Trade and Industry of South Africa. He has published two books on the WTO and over fifty journal entries, book chapters and briefing papers.

He is currently Senior Country Advisor (part-time) for Zambia for the International Growth Centre, a research network based at the London School of Economics and Oxford University, and Senior Associate of the African Centre for Economic Transformation, based in Accra Ghana.
