Students need to consult with the program convenor and motivate why taking the course will be helpful for dissertation research. Students should be aware of course credit weightings.</i></p>

Com in Economic Development students.</div><div>Students will be expected to deliver in writing a working dissertation title, proposal and confirmation of supervision to the program convenor in the final week of Year 1.</div><div>Students can seek co-supervision from outside of the economics department if the need arises and upon permission from the program convenor.</div></div>
