- Students wishing to be eligible for Honours in a particular discipline need to ensure that they register for the appropriate courses in that discipline.

**Additional information:**

- BUS3039 is not available to students who wish to pursue an Honours degree in Organisational Psychology. These students must take an alternative course at 3rd year level. Students may not register for both BUS2023S and BUS3039 within the degree programme.
